Eligibility:

This tournament is open to all male and female contestants registered and in good standing with the United States Judo Federation (USJF), United States Judo, Inc. (USJI), or the United States Judo Association (USJA) and must be a **minimum of five years old as of February 3, 2018.**

All contestants must present their valid USJF, USJI or USJA membership card at the time of registration. Any contestant unable to present their valid registration card will be required to purchase or renew membership prior to acceptance of the entry form for this tournament.

Contestant, the parents of minor contestants and the instructors have the responsibility of insuring that the contestant be familiar with the sport of Judo and have sufficient ability to safely compete in the tournament.

All contestants must compete in their own age and weight division prior to competing in a second division.

The weight divisions will be determined upon receipt of entries. Contestants who exceed the maximum weight allowed for their age group will be placed in the next older age group. Excessive weight contestants will be determined at the discretion of the tournament committee. Coaches, Instructors, and Parents will have an opportunity to review the categories and confirm their child's/athlete's suitability for participation.

Awards:

First, second, and third place awards will be given in each division. Awards will be presented after each division is completed. Contestants will be called to trophy presentation.

Tournament Rules

Current International Judo Federation (IJF) contest rules with the following modifications:

- True double elimination scoring will be used
- One IJF mat will be used
- 8M x 8M contest area with 3M safety area – no adjoining contest area
- The CARE System will not be used
- Shime-waza (choking techniques) will be allowed for 13 years and older
- Kansetsu-waza (joint lock techniques) will not be allowed in any division
- Golden Score time limit will be 2 minutes. First score wins match. Hantei decision will be called if tie remains
- Additional changes or modifications may be made to ensure the safety of participants.
- Co-ed competition for 10 years old and under
